ACTIVITIES

The following activities are encouraged to be met and maintained for year 2012:

- Encouraged to attend at least 18 events per year
- Encouraged to attend the initial orientation/training session (if unable to attend, a make-up session can be scheduled)
- Consistent attendance at quarterly meetings (can miss no more than 1 in a year)
- Encouraged to make at least three (3) contacts per month to notify Chamber members of upcoming events and to discuss other Chamber information. Comments are to be recorded on the monthly Ambassador form and submitted to the Chamber office.

POINT SYSTEM (in order to be in the running for Ambassador of the Year/Quarter)

30 Points

- Personal Visits
- Ribbon Cuttings (5 bonus points for an out of town event)
- Participation at major Chamber events, including the Annual Banquet, fundraisers, Christmas Parade or any other event designated as an Ambassador opportunity.

20 Points

- Business After Hours Attendance (5 bonus points for being a Greeter)
- Quarterly Ambassador Meeting
- New Member Reception Attendance
- Member Recruitment

10 Points

- Telephone interview/written correspondence
- Other Chamber Events (such as Member of the Week presentations, seminars, etc)

The Ambassador(s) accruing the most points by December 31, 2012 will be recognized as Ambassador of the Year at the 2013 Annual Meeting. An ambassador will be eligible to win the award once every three years. If the point spread separating the top eligible ambassadors is 10% or less, a committee will decide whether to present the award to one or to multiple recipients. The committee will consist of the past award recipient, the executive director and the current chairman of the ambassadors. If the ambassador chair is one of the possible recipients, then the third committee member will be the current president of the Chamber of Commerce.
